Access Application under Freedom of Information Act 2016 (ACT) - Access Decision

- 1. I refer to your email of 11 March 2024 in which you requested access to documents under the *Freedom of Information Act 2016 (ACT)* (FOI Act). Your request for documents was framed in the following way:
 - " 1. How many FOI requests were made to ACT ombudsman from 1/7/2020 till 29/2/24 inclusive?
 - 2. Of the requests in 1 above, how many were granted in full?
 - 3. Of the requests in 1 above, how many were refused or granted in part?
 - 4. Of the matters in 3 above, how many sought reviews by the ACT ombudsman under Division 8.2 of the Act?
 - 5. Provide copy of the FOI guidelines produced by the ACT ombudsman under s66 of the Act. If this is available online, provide the full link for its access.
 - 6. Of the matters in 4 above, how many of the ACT ombudsman review decisions were appealed to ACTA by the applicants?
 - 7. How many FOI decisions of ACT agencies were reviewed by the ACT ombudsman from 1/7/2020 till 29/2/24 inclusive? under Division 8.2 of the Act?
 - 8. Of the reviews in 7 above, how many were appealed to the ACTA by either party?"

Decision

- 2. This letter constitutes notice of my decision on your access application under section 51 of the FOI Act. The Ombudsman has appointed me as an information officer for the purposes of section 18 of the FOI Act. This appointment authorises me to make this decision.
- 3. Under section 43(1)(d) of the FOI Act, I may refuse to deal with an access application wholly or in part if the government information is already available to the applicant. Further, section 45(a) specifies that information is taken to be already available if it is publicly available. The majority of the information you seek in your access application is publicly available.
- 4. Items 1 (in part), 2, 3, 5 and 7 of your request are publicly available. I will provide links to where you can find the publicly available information. As such, I will exercise the discretion afforded to me in section 45(a) and will not be dealing with your access application in part.
- 5. The remaining information relating to items 1 and 4 of your request are contained in electronic documents and systems alongside information which is not relevant to your request. Considering the provisions at section 30 and section 47 of the FOI Act, I am providing access to 2 documents which contain the information sought. The information you have requested has been extracted from the electronic documents and systems to exclude out of scope information. Out of scope material that could not be separated from the information has been redacted.
- 6. There are no documents regarding items 6 and 8 of your request.
- 7. A schedule setting out the relevant documents containing the information sought is at **Attachment A.** Our Office identified this information by searching our electronic records management system, our case management system and electronic documents saved in a shared platform.
- 8. Please note that access applications made to our Office that are not for personal information are publicly available on our disclosure log available at: <u>Disclosure log I</u> ACT Ombudsman.

 - the file management systems in place
 - information publicly available in Ombudsman publications
 - advice from individuals and line areas within the office who may be able to assist.

Review rights

Ombudsman review

- 15. The review application must be made within 20 working days after the day this decision is provided to you.
