INSTRUMENT OF DELEGATION

I, Michael Manthorpe, ACT Ombudsman,

1. **revoke** all previous instruments of delegation issued under s 64(2) of the *Freedom of Information Act 2016* (the Act); and
2. **delegate** to any persons from time to time holding, occupying or performing the duties of positions and appointments in the Office of the Ombudsman specified in Column 1 of the Schedule to this instrument, the functions conferred on me by the provisions of the Act specified in the corresponding parts of Column 2 of the Schedule to this instrument. In relation to s 32(2) of the *Ombudsman Act 1989*, I am satisfied that there is a need for these functions to be exercised by a person who is not a public employee and that these people have expertise appropriate to the function delegated.
